

INFORMATION ABOUT THE VOLUNTARY TENDER OFFER PROMOTED BY IDEANOMICS INC.

Energica Motor Company S.p.A. ("**Energica**" or "**Company**"), a company operating in the market for the production and marketing of electric motorcycles and listed on Euronext Growth Milan, with reference to the voluntary tender offer ("**Offer**") promoted by Ideanomics Inc. ("**Ideanomics**" or "**Bidder**"), announces that today the offer document ("**Offer Document**"), approved by Consob with decision n. 22202 of 10 February 2022, was published on the Company's website (*www.energicamotor.com*) as well as on the Global Information Agent's website (*www.morrowsodali-transactions.com*).

The tender period of the Offer (the "**Tender Period**") will start at 8:30 (Italy time) on February 14, 2022 and will end at 17:30 (Italy time) on March 4, 2022.

The consideration, i.e. Euro 3.20 for each share tendered in the Offer ("Consideration") will be paid to the tendering shareholders on March 11, 2022 ("Payment Date").

Should the relevant conditions apply, the Tender Period might be re-opened for five consecutive trading days starting from the trading day immediately following the Payment Date, namely on March 14, 2022, March 15, 2022, March 16, 2022, March 17, 2022 and March 18, 2022 ("Re-opening of the Tender Period").

In case of Re-opening of the Tender Period, the Consideration related to the shares tendered in the Offer during the Re-opening of the Tender Period will be paid on March 25, 2022.
